No late submissions will be accepted.

It must therefore be understood that only quotations from suppliers registered on the Municipality's Supplier Database or quotations accompanied by a completed **Supplier Registration Application Form** will be considered. The submissions of valid up to date SARS tax clearance certificates are compulsory. Supplier Registration Application Forms are available from the Finance Department (Room 002) of the Municipality at 50 Market Street, VRYBURG, 8601.

The DR RUTH S MOMPATI DISTRICT MUNICIPALITY does not bind itself to accept the lowest or any quote and the Municipality reserves the right to accept the whole or part of any quote. No reasons for the acceptance or rejection of any quote will be given.

Quotations will be evaluated according to the DR RUTH S MOMPATI DISTRICT MUNICIPALITY's Supply Chain Management Policy, the Preferential Procurement Policy Framework Act (Act 5 of 2005) and the Preferential Procurement Regulations, 2011, Preferential Procurement Point System Applicable is 80/20 as well as the Broad Base Black Economic Empowerment Act (Act 53 of 2003).
