A non-refundable cash deposit fee of R250 is required on collection of the bid documents.

No late bids will be accepted.

It must therefore be understood that only bids from suppliers registered on the Municipality's Supplier Database or bids accompanied by a completed **Supplier Registration Application Form** will be considered. The submissions of valid up to date SARS tax clearance certificates are compulsory. Supplier Registration Application Forms are available from the Finance Department (Room 23) of the Municipality at 21 De Kock Street, VRYBURG, 8601.

The DR RUTH S MOMPATI DISTRICT MUNICIPALITY does not bind itself to accept the lowest or any bid and the Municipality reserves the right to accept the whole or part of any bid and further reserves the right to re-advertise if it so wishes to. No reasons for the acceptance or rejection of any bid will be given.

Bids will be adjudicated according to the DR RUTH S MOMPATI DISTRICT MUNICIPALITY's Supply Chain Management Policy, the Preferential Procurement Policy Framework Act (Act 5 of 2005) and the Preferential Procurement Regulations, 2011, as well as the Broad Base Black Economic Empowerment Act (Act 53 of 2003).
